The contract documents for both projects require the bidders to submit a list of subcontractors. There were also Minority/Women/Local business participation requirements. So the bidders should have provided the subcontract amounts.

Here is the applicable contract language:

Bidders are hereby informed that the FCAA encourages the utilization and participation of Minority and Women Business Enterprises and Local Businesses in contracts financed with Monroe County and Florida SRF funds. Bidders are encouraged to seek Minority and Women Business Enterprises and Local Businesses for participation in subcontracting opportunities. Contractors should use goals of 9% for MBE, 3% for WBE, and 15% of their Bid price for participation of locally owned businesses. Credit will be given in each category if a locally-owned business is also a MBE and/or WBE.
