

FKSPCA PROVIDES LOW-COST SPAY & NEUTER SERVICES FOR DOGS AND CATS AND THE OCCASIONAL EXOTIC PET. THE SERVICES ARE PROVIDED FREE OF CHARGE FOR PETS OF COMMUNITY RESIDENTS WHO ARE UNABLE TO PAY AND FOR ALL FERAL CATS AND ALL PIT BULL/PIT BULL MIXES. DURING 2014, FKSPCA SPAYED AND NEUTERED THE FOLLOWING ANIMALS: 203 OWNED DOGS AND 114 OWNED AND FERAL CATS, EXCLUDING SHELTER ANIMALS. SHELTER ANIMALS SPAYED OR NEUTERED IN 2014 TOTALED 331. IN 2014, A TOTAL OF 648 ANIMALS WERE SPAYED OR NEUTERED AT THE FKSPCA CLINIC.

THE VETS WHO WORK THE CLINIC PROVIDE THEIR SERVICES TO THE FKSPCA AT DEEPLY DISCOUNTED RATES. IN 2014, ALL OTHER CLINIC WORK WAS DONE BY VOLUNTEERS. IT IS ESTIMATED THAT OVER 3,400 HOURS OF CLINIC WORK ARE PERFORMED BY VOLUNTEERS.
